LEGAL DESCRIPTION:

That portion of the southwest 1/4 of Section 33, T.24 N., R.6 E., W.M., King County, Wash. lying Northerly, Westerly and Southerly of Timbercrest Division I, as recorded in Volume 94 of Plats, Pages 92 and 93 and assessor's plat of Mountain Park Estates as recorded in Volume 89 of Plats, Pages 57, 58, and 59, Records of King County, Washington; EXCEPT that portion thereof lying Southerly and Easterly of the following described line:

Beginning at the most Southerly corner of Lot 26 of said Timbercrest Division I, thence S43°55'17"E along the Westerly boundary of said Timbercrest Division I a distance of 839.43 ft.; thence S5°51'14"E continuing along said Westerly boundary a distance of 414.76 feet to the true point of beginning of the herein described line; thence N87°38'29"W a distance of 55.00 ft.; thence S50°19'41"W a distance of 254.19 ft.; thence S33°26'36"E a distance of 537.17 ft. to the South line of said Section 33 and the terminus of said line.

EASEMENTS:

An easement is hereby reserved for and granted to Puget Sound Power and Light Company and Pacific Northwest Bell, and their successors and assigns, under and upon the exterior 7 ft. parallel with and adjoining the street frontage of all lots and tracts in which to install, lay, construct, renew, operate and maintain underground conduits, cable, and wires with the necessary facilities and other equipment for the purpose of serving this subdivision and other property with electric and telephone service, together with the right to enter upon the lots at all times for the purposes stated.

ALSO, all lots shall be subject to an easement 2.5 ft. in width, parallel with and adjacent to all interior lot lines and 5 ft. in width, parallel with and adjacent to all rear lot lines for the purposes of utilities and drainage.

No lines or wires for the transmission of electric current or for telephone use, CATV, fire or police signals, or for other purposes, shall be placed upon any lot outside the buildings thereon unless the same shall be underground or in conduit attached to the building.

DEDICATION:

KNOW ALL MEN BY THESE PRESENTS that we, the undersigned owners in fee simple of the land hereby platted, hereby declare this plat and dedicate to the use of the public forever all streets and avenues shown thereon and the use thereof for all public purposes not inconsistent with the use thereof for public highway purposes, ALSO the right to make all necessary slopes for cuts and fills upon the lots and blocks shown on this plat in the original reasonable grading of the streets and avenues shown thereon. Tracts A, B, C, D, E, F, G, and H are hereby dedicated to the City of Issaquah for public purposes.
