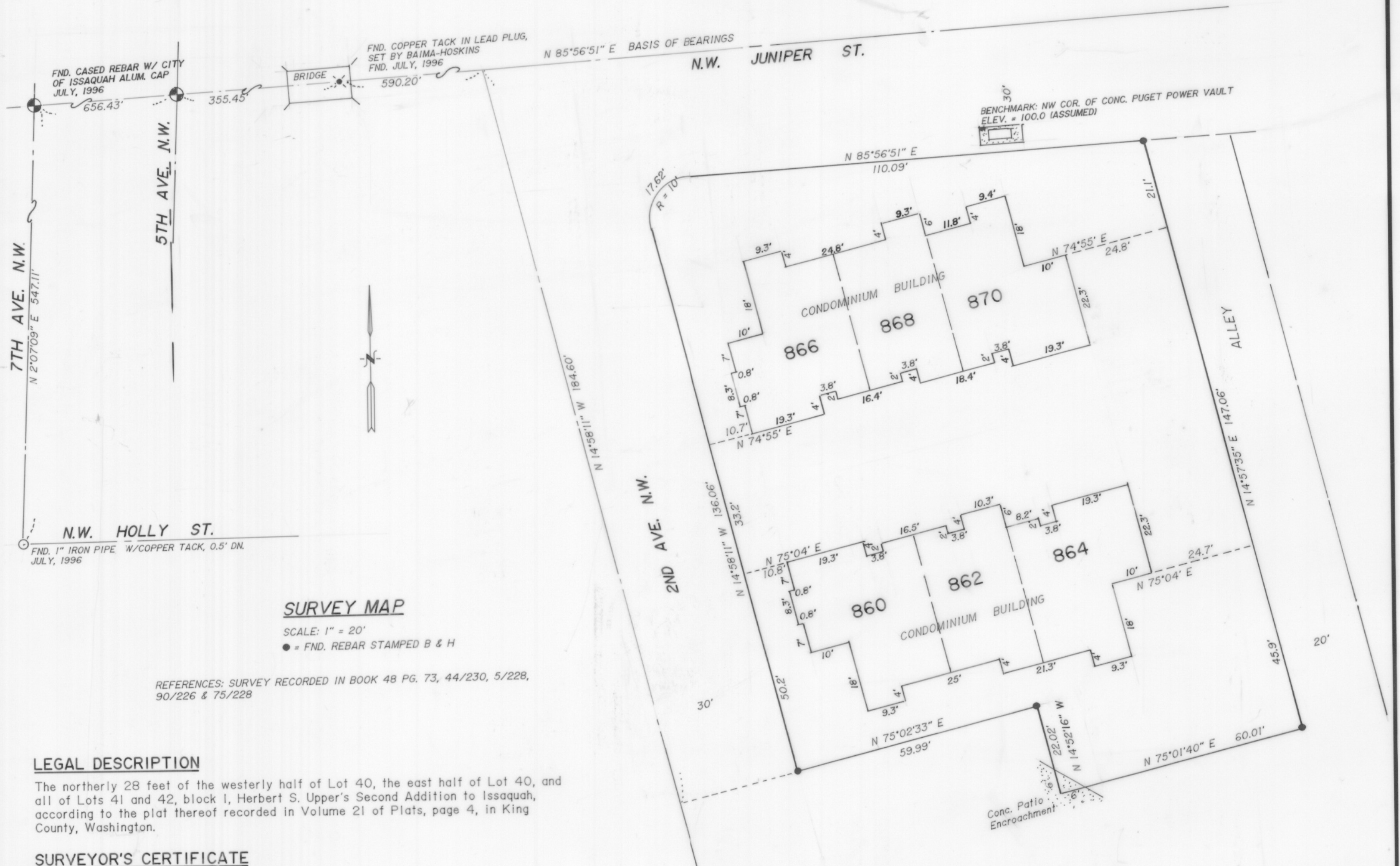


GILMAN TOWNHOMES, A CONDOMINIUM

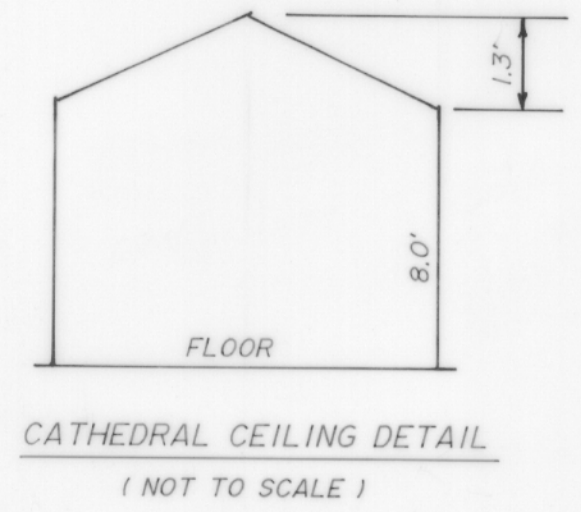
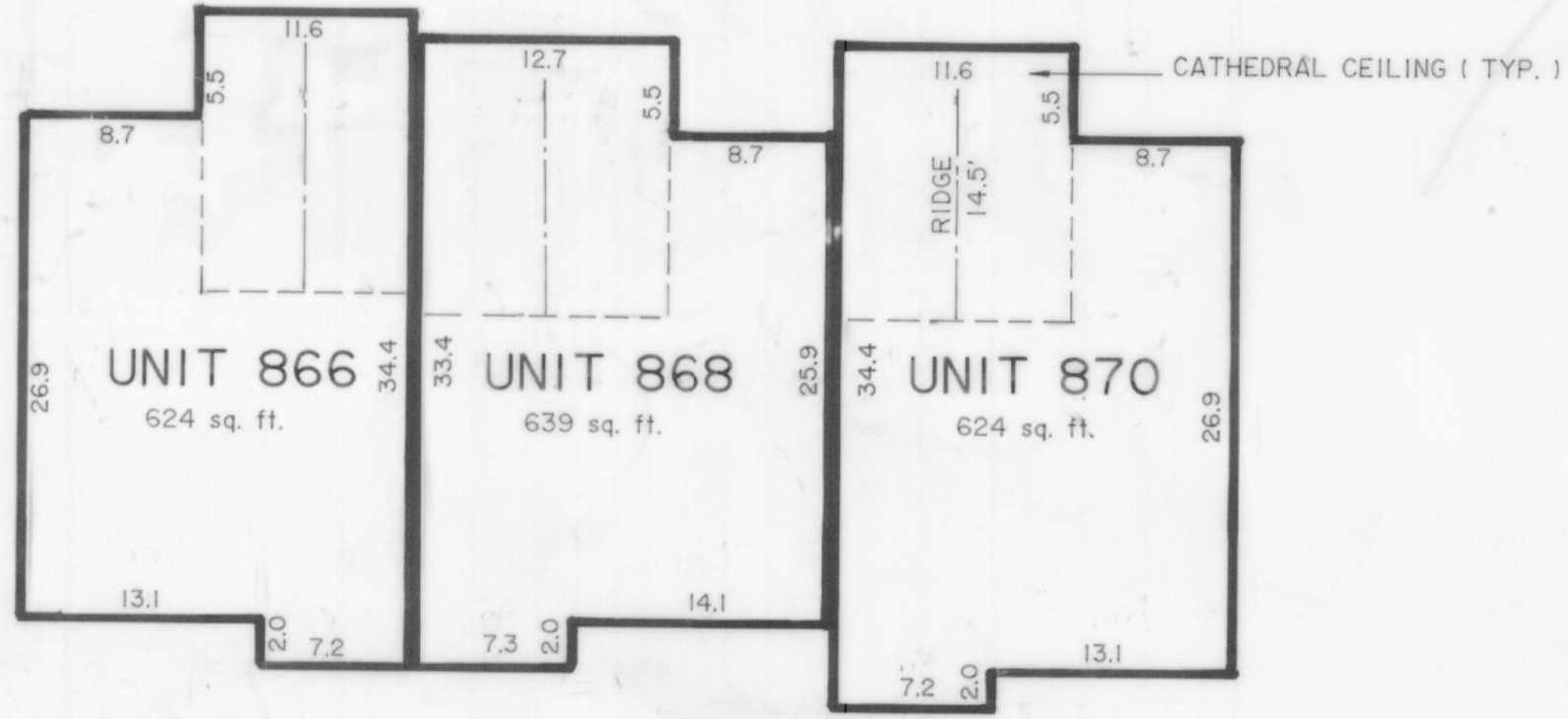
