- NO LOTS SHALL BE FURTHER SUBDIVIDED IF THE CREATION OF ADDITIONAL PLATTED LOTS IN A SUBSEQUENT SUBDIVISION WHEN TAKEN AS A WHOLE WITH THE PLAT DESCRIBED HEREIN WOULD BE IN SUBSTANTIAL NON-COMPLIANCE WITH PUD 79-04.
- NO DIRECT VEHICULAR ACCESS TO GILMAN BOULEVARD N.W. SHALL BE ALLOWED EXCEPT FROM ROADWAY EASEMENT TRACTS B AND F, EXCEPT LOT 12 WHICH SHALL BE ALLOWED ONE DIRECT ACCESS TO GILMAN BOULEVARD AS APPROVED BY PUD 79-04. NOTHING CONTAINED IN THIS NOTATION SHALL PRECLUDE MINOR RELOCATIONS OF THE ROADWAY EASEMENT TRACTS BY LOT LINE REVISIONS OR MAJOR RELOCATIONS SUBJECT TO THE PRIOR APPROVAL OF THE CITY OF ISSAQUAH.
