## LEGAL DESCRIPTION

That portion of Lot 1, Issaquah Short Plat No. 78-03 as recorded under King County Receiving No. 7901230711 and of Lot 3, Issaquah Short Plat No. 79-01 as recorded under King County Receiving No. 7903271108, in the west half of the west half of Section 28, Township 24 North, Range 6 East, W.M., in King County, Washington, all more particularly described as follows:

Beginning at the southeast corner of said Lot 3; thence N88°34'51"W along the south line thereof 354.75 feet to the TRUE POINT OF BEGINNING; thence N03°56'00"E 118.78 feet; thence N54°31'00"W 99.00 feet; thence N17°57'00"W 352.47 feet; thence N04°12'32"E 55.85 feet; thence N29°14'01"E 95.00 feet; thence N60°45'59"W 80.00 feet; thence N07°42'42"E 64.50 feet; thence N60°45'59"W 94.01 feet to the most southerly corner of Lot 25, The Woods at Issaquah, Division No. 1 according to plat recorded in Volume 110 of Plats, page 31 thru 33, records of King County, Washington; thence southerly along the easterly line of said plat by the following courses and distances: S67°10'37"W 73.74 feet; S33°03'33"W 100.00 feet; S81°15'28"W 47.28 feet; S04°59'44"W 80.16 feet; S01°25'09"W 160.00 feet; S88°34'51"E 15.00 feet; S01°25'09"W 80.00 feet; S88°34'51"E 30.00 feet; S01°25'09"W 80.00 feet; S88°34'51"E 15.00 feet; S01°25'09"W 80.00 feet; S88°34'51"E 10.00 feet; S01°25'09"W 307.95 feet to the north margin of Mt. ## EASEMENT PROVISIONS

An easement is hereby reserved for and granted to PUGET SOUND POWER & LIGHT COMPANY and PACIFIC NORTHWEST BELL and THE CITY OF ISSAQUAH, and their successors and assigns, under and upon the exterior 7 feet parallel with and adjoining the street frontage of all lots, in which to install, lay, construct, renew, operate and maintain underground conduits, cable, and wires with necessary facilities and other equipment for the purpose of service to this subdivision and other property with electric and telephone service, together with the right to enter upon the lots at all times for the purposes stated.

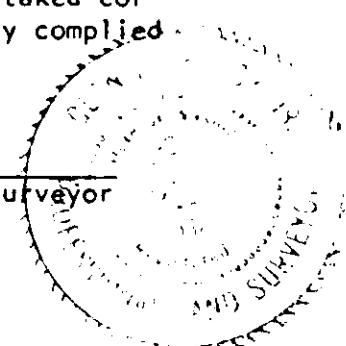
Also, all lots shall be subject to an easement 2.5 feet in width, parallel with and adjacent to all interior lot lines and 5 feet in width, parallel with and adjacent to all rear lot lines for purposes of utilities and drainage.

No lines or wires for the transmission of electric current or for telephone use, CATV, fire, or police signals, or for other purposes, shall be placed upon any lot outside the buildings thereon unless the same shall be underground or in conduit attached to the building.

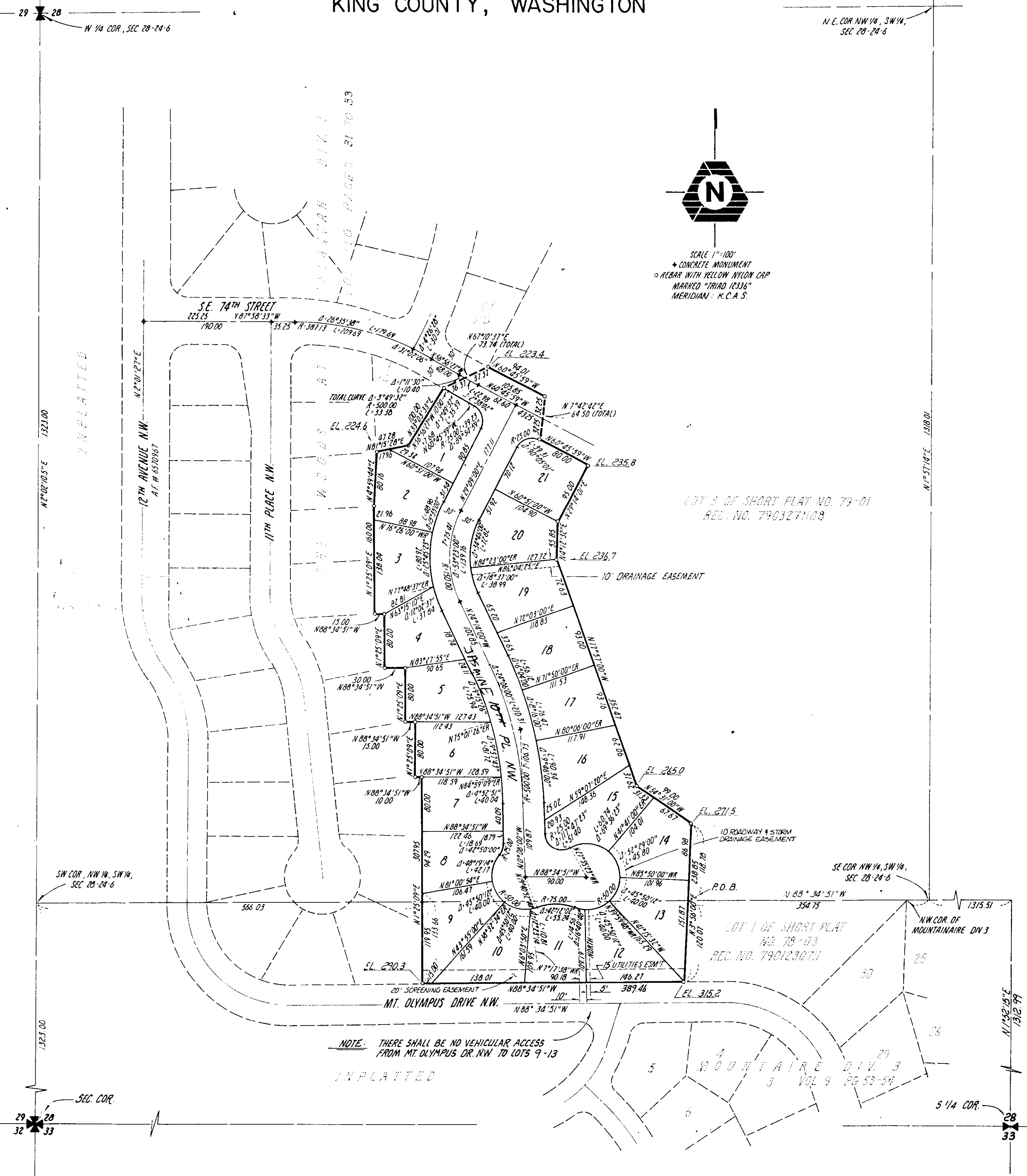
